**I. Requirements for the candidate:**

1. Master's degree in the field of biology or chemistry.
2. Very good knowledge of spoken and written English.
3. Required experience in carrying out research in biocrystallography (crystallization, diffraction measurements, solving and analyzing crystal structures), molecular biology (gene cloning, expression and mutagenesis) and biochemistry (overexpression, protein purification and analysis in solution).
4. Experience and readiness to tutor students.
5. Candidate should have an ability to solve research problems in an independent manner, enthusiasm for experimental work and ability to work as part of a team.

**II. Job responsibilities:**

1. Experimental work in the area of biocrystallography, molecular biology and biochemistry
2. Participation in preparing publications
3. Participation in other works carried out in the Department of Structure and Function of Biological Molecules

**III. Application must comprise:**

1. Letter of application to the Director of IBCH PAS with a declaration that the Institute will be the candidate's primary place of work and consent to be counted in "N" figure of the Institute (each researcher in Poland must submit a declaration to be within "N" figure accounted to a selected research unit).
2. Copy of master's diploma
3. CV featuring information on the candidate's scientific track record, including:
  - the list of papers published in journals listed in the Web of Science (WoS) database, stating the IF in accordance with WoS, number of citations and the H-index.
  - list of patents;
  - information on the previously managed projects or participation in project implementation;
  - information on the accomplished research internships;
  - information on the awarded prizes and distinctions.
4. Contact details of potential referees.

- *The legal basis for processing personal data is the Act of 26 June 1974 – The Labor Code, Act of 30 April 2010 on the Polish Academy of Sciences or the consent of the person whose data shall be subjected to processing.*
