## PRICE INQUIRY CONDUCTED IN ACCORDANCE WITH MARKET DISCERNMENT

### The price inquiry pertains to the execution of activities under the Project Purchase funded by the state budget from the Medical Research Agency, within the scope of the project:

# Development of a universal fast-response platform, based on RNA technology, ensuring national drug and epidemiological safety Grant agreement number: 2021/ABM/05/00004-00

The price inquiry is being conducted in adherence to market discernment principles as delineated in the guidelines of the Medical Research Agency.

## I. Description:

The contract entails the provision of 5 antisense oligonucleotides (ASO), a control oligonucleotide, and a reagent facilitating the delivery of antisense oligonucleotides to eukaryotic cells at the location specified by the Contracting Authority.

A comprehensive description of the contract is appended as Appendix No. 2 to this price inquiry.

#### II. Order completion date:

Order completion date: within a maximum of 15 working days from the order date.

#### III. Place, method, and deadline for submission of bids:

Bids should be submitted electronically to zampub@ibch.poznan.pl by July 28, 2025. Bids received after this date will not be considered. The bidding period is 30 days, concluding on 26 August, 2025. The Contracting Authority retains the right to terminate the proceedings at any time without providing reasons.

#### IV. Price:

Net prices of the bid must be expressed numerically. The Contractor must furnish a clear and definitive price in the submitted bid, which may be denominated in Polish zlotys, euros, or US dollars.



The price must be greater than zero and stated and calculated to two decimal places (rounding rule - below 0.005 should be rounded down, above and equal should be rounded up). The Beneficiary will compare net prices when evaluating bids.

The bid price must encompass all costs associated with the execution of the contract, to be borne by the Contractor, as well as the fulfillment of all Contractor's obligations and assumed risks stemming from unforeseen circumstances at the time of bid submission.

Failure by the Contractor to incorporate the aforementioned in the offered price shall not provide grounds for the Beneficiary to incur additional costs at a later date.

## VI. GDPR Information Clause.

The Beneficiary hereby notifies that the processing of personal data belonging to the Contractor and its business activities, individuals authorized to represent the Contractor in public procurement procedures, and data related to entities whose resources the Contractor invokes in this procedure, will be conducted in accordance with the provisions of Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council dated 27.04.2016, concerning the protection of natural persons concerning the processing of personal data and the free flow of such data, commonly known as GDPR. The designated Controller of the personal data is the Institute of Bioorganic Chemistry of the Polish Academy of Sciences in Poznań, located at ul. Z. Noskowskiego 12/14, 61-704 Poznań; REGON 000849327 NIP 777-00-02-062.

Personal data will be processed based on the following legal grounds:

- Article 6(1)(b) of GDPR, to undertake actions on behalf of the Contractor before the conclusion of a public procurement contract, during the conclusion of the contract, its execution, and settlement;

- Article 6(1)(c) of GDPR, to fulfill the Controller's obligations under the Public Procurement Law;

- Article 6(1)(f) of GDPR, to safeguard and assert potential claims of the Contracting Authority in the contract with the Contractor, as legitimate interests pursued by the Contracting Authority.

The retention period for personal data will extend throughout the cooperation with the Contracting Authority and for archiving purposes related to the documentation of the cooperation, in accordance with specific regulations or principles of contract financing. The Contractor has the right to access and rectify their data. The Contractor also possesses the right to file a complaint with the President of the Office for Personal Data Protection if there is a belief that the processing of personal data breaches GDPR provisions. However, it cannot be ruled out that these entities may be located outside the European Economic Area, in any country worldwide, unless legal provisions explicitly prohibit such data transfer. disclosed to authorities authorized by law and entrusted under a written entrustment agreement to entities cooperating with the Contracting Authority.
